This amendment by and between the Contractor and State Entity defined below shall be effective as of the date this Amendment is fully executed.

WHEREAS, the Contract is in effect through the Current Contract Term as defined above; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

The contract is being amended to note the following changes:

1. **Effective 07/01/2023** - The Menu will be modified as noted below and shall yield anticipated savings:

Approved Menu Changes	Anticipated Per Diem Cost Savings
Reduce Fruit/Canned Fruit at Breakfast to 3X per week.	(0.084)
Replace Fruit/Canned Fruit at Lunch with a variety of dessert items	(0.077)
Replace canned vegetable recipes with frozen vegetables.	(0.035)
Replace fortified fruit drink at Dinner with a tea beverage.	(0.005)
Total Savings from Menu Changes (Per Diem)	(0.201)

The current Per Diem price (per Inmate per Day) will change from \$3.108 to \$3.963 per diem.
The Weekend Snack cost will change from \$.40 to \$.60.
The Packaged Meal pricing will remain the same at Cost + \$3.93.

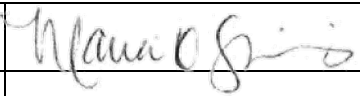
2. **Effective 09/01/2023** – Aramark will take over management of Staff Dining Operations at Coastal State Prison, Valdosta State Prison, and Arrendale State Prison.
 - **Section 13 (Staff and Visitor Meals)** of the contract shall be updated to Remove the “Note – Staff Dining at Coastal State Prison, Valdosta State Prison, and Arrendale State Prison will remain under GCI Operations and are not subject to the terms of this contract.”
3. **Effective 09/01/2023** –
 - a. **Smith State Prison** will be added to the Correctional Food Service contract and Aramark will assume all responsibility for management of Food Service Operations according to contract terms.
 - b. **Additional Weekend Sandwiches** – GDC will no longer purchase additional weekend sandwiches for the facilities. This will end on 08/31/2023.
4. **SUCCESSORS AND ASSIGNS.** This Amendment shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.
5. **ENTIRE AGREEMENT.** Except as expressly modified by this Amendment, the contract shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations to the parties. This Amendment and the contract (including any written amendments thereto), collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
